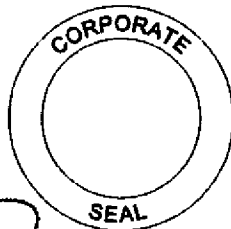
TOGETHER with all the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining.
